

## Terms & Conditions

1. Promoter

This competition is conducted by Lighthouse Presents Events (“Promoter”).

2. Competition Period

The competition commences at gate opening on the day of Lighthouse Rock 2026 and closes at the conclusion of the event.

3. Eligibility
